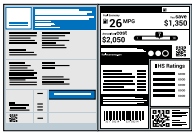

**Glossary****CARFAX Homegrown™**

A vehicle that was originally sold new by a dealership and is now being evaluated or sold again by that same dealership. At least 75% of the vehicle's reported service was also performed there, meaning the dealership has handled most of its care and maintenance.
